The NLBRA Executive Board is accepting applications for these positions for the NLBFR: 3 Judges for each Arena, 2 Judges for the Track, 3 Pick-up Men, 3 Bullfighters, 3 Announcers, and 1 Lead Secretary. Please forward this information to anyone who might be interested in applying. **The deadline for applying is December 11, 2009.**

The National Little Britches Finals Rodeo will be held July 26 –31, 2010, in Pueblo, Colorado. Contracted personnel must be in Pueblo by Saturday, July 24, 2010, 12-noon for pre Finals preparation. Those interested in working the rodeo must submit a completed NLBFR application via certified mail, fax or e-mail including all references by December 11, 2009. If the applicant is interested in applying for more than one position only one application needs to be submitted. Incomplete applications or applications without references and/or a resume will not be considered. Anyone who applied for a position in 2009 will only need to update the first page of the application unless they wish to submit updated resume and/or references. In 2009, 889 contestants competed during the 11 rodeo performances, which ran approximately 4.5 hours each.

The appropriate Arena Directors and Track Director will review applications for Judges, Bullfighters and Pick-up Men and recommendations will be made to the NLBRA Executive Board. The NLBRA Executive Board will select personnel for all finals personnel positions at the January 23 & 24 meeting. The NLBRA Executive Board reserves the right to accept or deny any application.

NLBFR PERSONNEL COMPENSATION PLAN

The compensation plan is as follows:

- **Judges:** 8 positions, \$100 per performance (\$1,100)*, Timed Arena Judges (3) will also be provided with a pen for flag horse
- **Bullfighters:** 3 positions, \$900*
- **Pick Up Men:** 3 positions, \$900*, plus outside pens for horses
- **Announcers:** 3 positions, \$1,300*
- **Lead Secretary:** 1 position, \$1,500*
- **Producer:** Bid will be provided for this position
- **Photographer:** Bid will be provided for this position

*These positions also receive the option of a hotel room or camp space from Sat., July 24 checking out Sun., Aug. 1.

DEADLINE: Applications must be sent via certified mail, postmarked no later than December 11, 2009. If you choose to email or fax your application, it is your responsibility to verify with the NLBRA National Office that your application has been received prior to 12 noon on December 11, 2009.

Notes:

Applications for Timers (6) and Division Secretaries (4) will be taken after the lead secretary is approved. Applications for these positions will be available after February 19, 2010 with an anticipated application deadline of March 19, 2010. Each position will be compensated at a rate of \$825 and includes a hotel room or camp spot.

- If you applied, for a Finals Personnel position, in 2009 then your resume and references are still on file and you only need to submit the Finals Personnel Application; however, you have the option of changing your resume and/or references.
- If you are a new applicant then you must submit three (3) reference letters and a resume. These letters and your resume also must be received by December 11, 2009.
