ENTRY FORM

MB RULES

- 1) MB Contestants shall weigh less than 50 pounds. MB Contestants may be weighed prior to event and if more than 50 lbs may forfeit their entry.
- 2) MB Contestants will ride for 6 seconds.
- 3) MB Contestants will be timed and judged. All decisions are final.
- 4) MB Contestants can enter as many times as they like; however, NLBRA will limit the number of rides to 20 per day. Rides will take place during the evening rodeo performance, which begins at 6 p.m. If entered, MB Contestants should be ready to go by 5:30 p.m. Entries close when NLBRA reaches 20 per performance. MB entries may be accepted up to 5:30 the day of the contest if there is a lack of entries.
- 5) The cost to enter is \$25. This is for one ride during an evening performance at the National Little Britches Finals Rodeo with an opportunity of making the Championship Round and competing on Saturday, July 31 at 10 a.m. The top two rides from each performance will qualify to ride again in the Championship Round on Saturday. There will be no entry fee to the Saturday MB Championship Round.
- 6) A parent or guardian must sign a release form and be present during the time of the event.
- 7) MB Contestants will be provided and are encouraged to wear protective helmets and vests.
- 8) The MB Contestant also agrees to ride in traditional NLBRA attire, which includes western clothing, a long sleeve western shirt with collar and cuffs, jeans and boots.

Each MB Contestant will receive free admission for themselves and two fans, \$15 value.

- If the MB Contestant makes it into the championship round he/she will receive another set of tickets for 2 guests. MB Contestants will be admitted free by wearing Official MB Contestant back number.

CONSENT RELEASE AND WAIVER OF LIABILITY\ AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter for any purpose any **RESTRICTED AREA** (herein defined as including but not limited to the arena, competition area, chutes, pens, areas reserved and intended for participants or restricted to the general public, and all walkways, concessions and other areas appurtenant to any area where any **NLBRA** event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in any **NLBRA** event, **EACH OF THE UNDERSIGNEDS**, for themselves, their spouses, guests, children, personal representatives, heirs, and next of kin, acknowledge, agree and represent that they have, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which they enter and with which they come in contact, and they do further warrant that their entry upon such restricted area or areas and their participation, if any, in the event constitutes an acknowledgment that they have inspected such restricted area and that they find and accept the same as being safe and reasonably suited for the purposes of their use, and they further agree and warrant that if, at any time, they are in or about restricted areas and feel anything to be unsafe, they will immediately advise the officials of such and will leave the restricted areas; and

1. HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the participants, sanctioning organization or any subdivision thereof, rodeo committee, stock contractor, rodeo association, arena operators or owners, officials, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases", from all liability to the undersigned, their agents, personal representatives, assigns, heirs, and next of kin for any and all loss of damage, and any claim or demand therefore on account of injury to the person, property, or death of the undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is in or upon the restricted area, and/or, competing, officiating, observing, working for, or for any other related purpose; and

2. HEREBY AGREES TO INDEMNIFY, AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by the negligence of the releases or otherwise; and

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OF PROPERTY DAMAGE due to the negligence of releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage. **EACH OF THE UNDERSIGNED** further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as in permitted by the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

WE HAVE READ THIS DOCUMENT. WE UNDERSTAND IT IS A RELEASE OF ALL CLAIMS.

WE UNDERSTAND WE ASSUME ALL RISK INHERENT IN RODEO RELATED ACTIVITIES.

WE VOLUNTARILY SIGN OUR NAME EVIDENCING OUR ACCEPTANCE OF THE ABOVE PROVISIONS.

IN THE EVENT OF THE SIGNATURE OF ONLY ONE PARENT OR GUARDIAN, SUCH PARENT OR GUARDIAN HAS THE AUTHORITY TO BIND BOTH PARENTS AND GUARDIANS WITH HIS/HER SIGNATURE.
